AFFIDAVIT NO 2. OF MICHAEL KRESTELL

Sworn on July 24, 2023

I Michael Krestell, of the City of Thornhill, in the Province of Ontario, MAKE OATH AND SAY THAT:

- This Affidavit is made in support of the application (the "Application") by Dynaleo Inc. ("Dynaleo") and Dynaleo Group Services Inc. ("Dynaleo Services" and together with Dynaleo, the "Companies") returnable July 31, 2023, before the Court of King's Bench of Alberta (the "Court").
- 2. I am the Executive Chairman and director of each of the Companies. As such, I have personal knowledge of the Companies and matters to which I depose in this Affidavit. Where I have relied on other sources for information, I have so stated and I believe them to be true.
- I have previously sworn an affidavit in these proceedings on May 24, 2023 (the "First Krestell Affidavit") in support of the May 30, 2023 Order (as defined below).
- Unless otherwise stated, monetary figures in this Affidavit are expressed in Canadian dollars.

INTRODUCTION

- 5. As noted in the First Krestell Affidavit, on May 23, 2023, the Companies filed a notice of intention to make a proposal (the "NOI") under section 50.4(1) of Bankruptcy and Insolvency Act (Canada) (the "BIA"). The NOI was filed in consultation with the Companies' professional advisors to attempt to restructure the Companies for the benefit of their stakeholders and after identifying no viable alternative process due to the Companies' insolvency (the "NOI Proceeding").
- Pursuant to section 50.4(8) of the BIA, the initial stay period under the NOI Proceeding was from May 23, 2023 to June 22, 2023.
- On May 30, 2023, on application by the Companies, the Court granted an order (the "May 30, 2023 Order") that, among other things:
 - (a) appointed Harris & Partners Inc. as the proposal trustee in the NOI Proceeding (the "Proposal Trustee");

- (b) approved a sale and investment solicitation process (the "SISP") described in the Proposal Trustee's first report to the Court dated May 24, 2023 (the "First Report") and authorized and directed the Companies and the Proposal Trustee to carry out the SISP;
- granted a charge, not to exceed \$200,000, as security for the fees and costs of the Proposal Trustee, its independent legal counsel, and legal counsel to the Companies;
- (d) granted a Directors' and Officers' Charge over the assets and property of Dynaleo only, to a maximum amount of \$75,000, in favour of the directors and officers of the Companies;
- (e) extended the time for filing a proposal pursuant to section 50.4(9) of the BIA up to and including August 5, 2023; and
- (f) consolidated, for procedural purposes only, the Court of King's Bench of Alberta Bankruptcy and Insolvency Estate Nos. 24-2946871 and 24-2946872 into Estate No. 24-2946872.
- 8. Capitalized terms used and not otherwise defined herein have the meanings ascribed to them in the First Krestell Affidavit.

NATURE OF APPLICATION AND OVERVIEW OF RELIEF SOUGHT

- 9. This Affidavit is made in support of the Application for orders, among other things:
 - (a) abridging the time for service of this Application and the supporting material, if necessary, and deeming service thereof to be good and sufficient;
 - (b) extending the time by which the Companies may file proposals to their creditors pursuant to section 50.4(9) of the BIA to September 19, 2023, which is the 45-day maximum period following the current deadline to do so;
 - (c) if necessary, approving a litigation schedule between the Companies and Peace Naturals Project Inc. ("PNP") to hear the Disclaimer Dispute (as defined below); and

- such further and other relief as counsel may request and this Honourable Court may deem appropriate.
- 10. I have been advised by the Proposal Trustee that it supports this Application.

BACKGROUND

Operations and Organization

- 11. The Companies are private companies in the business of producing and distributing cannabis infused gummies.
- 12. Dynaleo is incorporated pursuant to the *Business Corporations Act,* RSA 2000, c B-9. Its registered office is located at 2500-10175 101 Street NW, Edmonton, Alberta.
- 13. Dynaleo Services is incorporated pursuant to the Canada Business Corporations Act, RSC 1985, c C-44.
- 14. The Companies together are in the business of producing and distributing the highest quality cannabis-infused edible gummies (the "**Product**").
- 15. Dynaleo Services manages the production of the Product and at its peak employed approximately 65 full-time employees.
- 16. Dynaleo owns the equipment and supplies necessary for the production of the Product. Dynaleo also holds the lease in which the Companies operate out of and is responsible for distribution of the Product to the Companies' customers.
- 17. The Companies are insolvent and each filed a Notice of Intention to Make a Proposal (the "NOIs") with the Official Receiver on May 23, 2023, in order to restructure their affairs for the benefit of their stakeholders.

The SISP

18. As set out in the First Krestell Affidavit beginning at paragraph 75, and the First Report beginning at paragraph 36, the Companies, with support of the Proposal Trustee, sought and obtained approval of the SISP to undergo a restructuring process and allow all qualified and interested parties to solicit interest in, and opportunities for, a sale of, or investment in, all or part of the Companies' assets and business operations (the "Opportunity").

19. The Companies commenced the SISP in June 2023. The SISP was designed to be flexible, such that any proposed transaction structure would be considered, whether it be for shares, or assets of the Companies, or any combination of these transactions.

21. As detailed in the First Report, the Companies and Proposal Trustee worked together to prepare a list of Potential Bidders, including: (i) parties that have approached the Companies and/or the Proposal Trustee indicating an interest in the Opportunity, (ii) strategic and financial parties who the Companies, in consultation with the Proposal Trustee, believe may be interested in purchasing all or part of the Business and Property or investing in the Companies pursuant to the SISP.

Results of the SISP

- 22. In June 2023, the Proposal Trustee circulated to interested parties a process summary (the "Teaser Letter") describing the Opportunity, outlining the process under the SISP and inviting recipients of the Teaser Letter to express their interest in the opportunity. A copy of the Teaser Letter is attached to my Affidavit as Exhibit "A".
- 23. Interested parties were requested to submit an executed non-disclosure agreement, letter setting forth the required information as laid out in the SISP, and a form of financial disclosure and credit quality support to enable the Companies and Proposal Trustee to understand the Potential Bidder's ability to consummate a potential transaction.
- 24. If the Companies, in consultation with the Proposal Trustee, determined that a Potential Bidder satisfied the requirements of the SISP, then the Potential Bidder was deemed to be a "**Phase 1 Qualified Bidder**".

- A Phase 1 Qualified Bidder that wished to pursue the opportunity further was required to deliver a non-binding letter of intent (an "LOI") to the Proposal Trustee by 5:00 p.m.
 MST on June 23, 2023 (the "Phase 1 Bid Deadline").
 - 26. Five Phase 1 Qualified Bidders submitted an LOI by the Phase 1 Bid Deadline.
 - 27. Following the Phase 1 Bid Deadline, the Companies, in consultation with the Proposal Trustee, assessed the LOIs and selected certain parties to advance as a "Phase 2 Qualified Bidder" in the SISP.
 - 28. Two Phase 2 Qualified Bidders submitted binding offers by the Bid Deadline (each, a "Binding Offer"). Following receipt of the Binding Offers, the Companies, with the assistance of the Proposal Trustee, have been working with the Phase 2 Bidders to reconcile certain closing conditions in their respective bids.
 - 29. Pursuant to the SISP, any deadlines, including the Closing Date Deadline, can be extended in order to pursue the two binding offers in hopes of closing the transaction.
 - 30. The Companies, with the assistance of the Proposal Trustee, anticipates returning to this Court in the near future for approval of one of the transactions with a Phase 2 Qualified Bidder.

DISCLAIMER DISPUTE

- 31. On July 29, 2022, Dynaleo entered into a Contract Manufacturing Agreement (the "Manufacturing Contract") with PNP, a subsidiary of Cronos Group Inc. ("Cronos"), which is a large brand leader in the cannabis-infused edible gummies business. The Manufacturing Contract was set to expire July 29, 2023.
- The Manufacturing Contract was for the Companies to produce Product for PNP.
- 33. As part of the Manufacturing Contract, Dynaleo was required by PNP to make significant capital expenditures to acquire specialized machinery to meet the volume and Product specifications for PNP.
- 34. In return for these expenditures by Dynaleo, it was a term of the Manufacturing Contract that upon the expiration or termination of the Manufacturing Contract, PNP agreed to pay Dynaleo an equipment fee (the "Equipment Fee").

- 35. In addition, it was a term of the Manufacturing Contract that upon the termination of the Manufacturing Contract, PNP would reimburse Dynaleo for certain costs of PNP specific materials that PNP required that Dynaleo purchase based on PNP's purchasing forecasts (the "Materials Fee").
- 36. Beginning on June 1, 2023, Cronos requested the return or destruction of certain of its property that was required for the manufacturing of Product for PNP, signaling that PNP would not be making further orders for Product despite there being approximately two months' remaining on the Manufacturing Contract.
- 37. As a result, on June 15, 2023, Dynaleo sought to mutually terminate the Manufacturing Contract and requested payment of the Equipment Fee and Materials Fee.
- 38. After waiting two-weeks and receiving no response on Dynaleo's mutual termination request, and with PNP not having made any more orders under the Manufacturing Contract, on June 28, 2023, with the approval of the Proposal Trustee, the Companies issued a notice of disclaimer to PNP in respect of the Manufacturing Contract (the "Disclaimer") in accordance with s 65.11 of the BIA. A copy of the Disclaimer is attached as Exhibit "B".
- 39. Concurrently with the Disclaimer, solicitors for the Companies sent PNP a demand for the Equipment Fee and Manufacturing Fee, each of which is payable upon the termination of the Manufacturing Contract (the "Demand Letter"). A copy of the Demand Letter is attached as Exhibit "C".
- 40. On June 30, 2023, in-house counsel to PNP requested that the Companies provide written reasons ("**Request for Written Reasons**") for the Disclaimer within five days pursuant to section 65.11(9) of the BIA. The Request for Written Reasons is attached to my Affidavit as Exhibit "**D**".
- 41. In accordance with the timelines required by section 65.11(9) of the BIA, the Companies provided written reasons (the "Written Reasons") for the Disclaimer to PNP on July 5, 2023. A copy of the Written Reasons is attached as Exhibit "E".
- 42. On July 20, 2023, counsel for Cronos and PNP sent a letter (the "July 20 Letter") to counsel for the Companies requesting, among other things, that the Companies withdraw the Disclaimer. A copy of the July 20 Letter is attached as Exhibit "F".

- 43. On July 21, 2023, counsel for the Companies wrote to counsel to Cronos and PNP in response to the July 20 Letter (the "July 21 Letter"). A copy of the July 21 Letter is attached as Exhibit "G".
- 44. I understand that Cronos and PNP intend to bring an application to: (i) extend the 15day period for which it can file an application to dispute the Disclaimer, and (ii) if the extension is granted, seek an order declaring that the Manufacturing Contract cannot be disclaimed (the "Disclaimer Dispute").
- 45. On July 24, 2023, counsel to Cronos and PNP wrote to counsel for the Companies (the "July 24 Letter") indicating that they intend to file an application in relation to the Disclaimer Dispute that day, returnable July 31, 2023. A copy of the July 24 Letter is attached to my Affidavit as Exhibit "H".
- 46. In the event that Cronos and PNP proceed with the Disclaimer Dispute, the Companies may seek approval of a litigation schedule to ensure that the Disclaimer Dispute is determined expeditiously and in any event prior to the expiry of the time for filing a proposal.

RELIEF REQUESTED

Extension of Time to File a Proposal

- 47. An extension of time for the Companies to file a proposal or proposals is a material component of the NOI Proceeding to allow the Companies to restructure their affairs, including negotiating and completing the SISP and closing one of the transaction of the Phase 2 Qualified Bidders.
- 48. Since filing the NOI, the Companies have been diligently complying with the various requirements under the BIA, including:
 - (a) preparing and analyzing the list of creditors;
 - (b) providing the Proposal Trustee with access to the Companies' senior employees and books and records;
 - (c) completing a cash flow forecast to the week ending August 18, 2023;
 - (d) implementing and executing the SISP; and

- (e) working with the Proposal Trustee to review and analyse the Binding Offers submitted in the SISP in order to pursue one of the transactions.
- 49. The Companies are working in good faith and with a view to maximize value for the Companies' creditors and other stakeholders.
- 50. I understand that in order to continue to work toward the formulation and filing of a proposal or proposals, the Companies will require an extension of the time period within which they may file a proposal or proposals to their creditors. In this regard:
 - the Companies have acted and are acting in good faith and with due diligence both in the period prior to and since filing of the NOIs; and
 - (b) an extension will enhance the Companies' abilities to make a viable proposal or proposals following the completion of a transaction.

CONCLUSION

- I swear this Affidavit in support of the Application and any other proper purpose in connection with these NOI proceedings.
- 52. I was not physically present before the commissioner when swearing this Affidavit but was linked with the commissioner utilizing video technology and that the protocol described in the Alberta Court of King's Bench Notice to the Profession and Public dated March 25, 2020 with respect to remote commissioning of Affidavits was followed.

Company Background

Dynaleo Inc. ("Dynaleo" or the "Company") is a business that offers cannabis infused edible products with a state of the art facility in Nisku, Alberta. 





REASONS FOR DISCLAIMER PURSUANT TO SECTION 65.11(9) OF THE BIA

To: Peace Naturals Project Inc. ("PNP")

Whereas:

- A. On May 23, 2023, Dynaleo Inc. ("Dynaleo" or the "Company") commenced proposal proceedings (the "Proposal Proceedings") under the Bankruptcy and Insolvency Act (the "BIA") and Harris & Partners Inc. was appointed as the proposal trustee ("Proposal Trustee") in the BIA Proceedings ("Proposal").
- B. On June 28, 2023, in accordance with subsection 65.11(1) of the BIA, the Company gave PNP notice of its intention to disclaim or resiliate a Contract Manufacturing Agreement dated July 29, 2022 made between PNP and the Company ("Agreement").
- C. On June 30, 2023 at 4:29 pm (MDT), PNP requested reasons in writing for the disclaimer of the Agreement pursuant to subsection 65.11(9) of the BIA. The requested reasons are set out below.

Reasons for Disclaimer

The Company considered a number of factors in determining to disclaim the Agreement including:

- Leading up to and following the commencement of the Proposal Proceedings, the Company, in consultation with the Proposal Trustee, undertook a review of certain contracts to consider whether disclaiming them would assist improve the Company's challenging liquidity position and/or facilitate the prospect of a viable proposal being made by the Company.
- 2. There was limited on-going business operations occurring between the Company and PNP pursuant to the Agreement prior to the commencement of the Proposal Proceedings. During the Proposal Proceedings, the Company fulfilled two orders from PNP, identified as Order Number: 2023-00893-00 and Order Number: 2023-00893-01 ("Orders"), which PNP has paid for in full in accordance with the terms of the Agreement. Since that time there has been no further business occurring between the two parties and no further business will occur as the Company has ceased fulfilling orders.
- 3. As part of the Proposal Proceedings, the Company commenced a Court-approved sale and investment solicitations process (the "SISP") to seek to identify a potential sale or restructuring transaction that would maximize the value of the Company's business for the benefit of the Company and its stakeholders. Prior to determining whether to disclaim the Agreement, the Company waited for the results of the first phase of the SISP. Thereafter, the Company considered the letter of intent submitted by PNP and those received from other partied and considered whether disclaiming the Agreement would negatively impact the SISP.
- The Company determined that the disclaimer of the Agreement would not negatively impact the outcome of the SISP.
- The Company reviewed the nature, terms, and purpose of the Agreement in detail, and believes that the Agreement does not constitute any of the types of contracts that are exceptions to the statutory regime of Section 65.11 of the Act.
- The Company believes disclaiming the Agreement will improve its liquidity and enhance the prospects of a viable proposal being made by the Company.

 The Company consulted with the Proposal Trustee and the Proposal Trustee reviewed and approved of the Company's disclaimer of the Agreement prior to it being issued.

As you are aware, we are counsel to Cronos Group Inc. ("Cronos") and Peace Naturals Project Inc. ("PNP") in connection with the above-noted matters. We are writing with respect to the disclaimer notice (the "Disclaimer") provided by Dynaleo Inc. ("Dynaleo"), dated June 28, 2023, which states that Dynaleo intends to disclaim the Contract Manufacturing Agreement between Dynaleo and PNP agreed to as of the 29th day of July 2022 (the "Agreement"). Capitalized terms used but not otherwise defined herein shall have the meanings given to them in the Agreement.

We are also in receipt of your e-mail dated July 19, 2023 (the "E-mail") wherein you condition an earlier agreement to extend our client's time to object to the Disclaimer (which we understand was agreed to without details with former counsel to Cronos and PNP) and the return of Moulds and Direct Materials on payment of the Equipment Fee by our client.

Based on our review of the materials filed in the Proceedings, including the "Reasons for Disclaimer Pursuant to Section 65.11(9) of the BIA" provided by Dynaleo to our client on July 5, 2023, the Disclaimer does not appear to serve any legitimate purpose under the *Bankruptcy and Insolvency Act*, RSC 1985, c B-3 ("BIA"). Further, there is no evidence to suggest that the Disclaimer "would enhance the prospects of a viable proposal being made in respect of" Dynaleo.

As you know, at the time of the Disclaimer, there were no ongoing performance obligations of Dynaleo to PNP under the Agreement, which will expire on its terms on July 29, 2023. On expiration of the Agreement, the only amounts which may be owing from PNP to your client would be the Equipment Fee, which is under review by PNP in light of Section 6(e) of the Agreement. It appears that the Disclaimer was issued, with a view to creating a "termination" of the Agreement, one day prior to its expiration in an attempt by your client to fabricate a claim against our client which is not supported by the Agreement or the general requirement that a debtor in BIA proposal proceedings must act in good faith in carrying out its restructuring proceedings.

Our client is not prepared to accept the terms set out in the E-mail for an extension of time to object to the Disclaimer. If your client is not prepared to withdraw the Disclaimer immediately, our client intends to make an application to the Court of King's Bench of Alberta for an order: (i) that the Agreement cannot be disclaimed; (ii) requiring the immediate return of the Moulds and Direct Materials; and (iii) declaring that no amounts are owing from our client to Dynaleo. In any such application, our client intends to seek costs as against your client.

Dear Madame:

We are counsel to Dynaleo Inc. and Dynaleo Group Services Inc. (collectively, "Dynaleo"). We write in response to your letter dated July 20, 2023, as counsel to Cronos Group Inc. and Peace Naturals Project Inc. (collectively, "Cronos"). Capitalized terms used herein and not otherwise defined have the meanings given to them in the Contract Manufacturing Agreement dated July 29, 2022 between Dynaleo and Cronos (the "Agreement") or your letter.

Extension of time to object to Disclaimer

We disagree with the assertion that Dynaleo agreed to an indefinite extension of time for Cronos to bring an application to object to the Disclaimer. In anticipation of being retained by Cronos, Torys LLP informally asked for an extension to object to the Disclaimer if they were ultimately retained and instructions were ultimately received to do so. This counsel was to contact me once retained and instructions were received to formalize the request. No call was made and this counsel was ultimately not engaged for this issue. No agreement as to the terms for an extension for Cronos to object to the Disclaimer was ever established. Enclosed is correspondence between me and Torys LLP showing that Torys LLP never received instructions regarding the Disclaimer extension request.

The first time we received confirmation that Cronos intended to dispute the Disclaimer was a full week later, when your office was engaged. Cronos' first official request for an extension from its retained counsel that had instructions was made July 17, 2023, four days after the 15 day deadline for Cronos to file its application under s. 65.11(3) of the *Bankruptcy and Insolvency Act* (Canada) ("**BIA**") had expired.

Cronos at all times was aware of the strict timelines required by the BIA pertaining to disclaimer notices and held Dynaleo to those strict timelines when it requested written reasons

for the Disclaimer. Enclosed is a copy of this correspondence from Cronos Deputy General Counsel to this effect.

To date, no extension of time to bring a s. 65.11(3) BIA application was agreed to between the parties. Even if a reasonable extension was granted by Dynaleo as alleged, waiting a full week to confirm Cronos' intentions to dispute the Disclaimer is unreasonable. Cronos is out of time to bring an application objecting to the Disclaimer, which, but for Cronos' early termination of the Agreement discussed below, otherwise would have become effective on July 28, 2023, by operation of s. 65.11(6)(a) of the BIA.

Early Termination of the Agreement by Cronos

As you know, section 6(d) of the Agreement states "Upon expiration or termination of this Agreement, Dynaleo shall ship the Moulds to [Cronos] as soon as reasonably practicable ... or as otherwise mutually agreed by the Parties in writing". It has always been the intention of Dynaleo to return the Moulds following termination of the Agreement. Your letter is a further request from Cronos for the Moulds prior to the expiry of the Agreement. We accept this request as confirmation the Agreement has been terminated effective immediately.

Given this termination of the Agreement, Dynaleo has initiated steps to return the Moulds to Cronos. Dynaleo expects to be in a position to deliver the Moulds to Cronos by mid-next week. If Cronos wishes to pick-up the Moulds, please advise.

With respect to the Direct Materials, since early June Dynaleo has tried to facilitate the winddown of the contractual relationship and the return of the Direct Materials to Cronos. As has been repeatedly stated to your client by Dynaleo and the Proposal Trustee, before Dynaleo can release the Direct Materials to Cronos, the Proposal Trustee needs to complete an inventory to confirm which property Cronos has an ownership interest in. Enclosed are emails from June 8, 2023, and June 15, 2023, to Cronos from the Proposal Trustee and Dynaleo, respectively, requesting this information. Cronos did not respond to either of these emails.

My email from Wednesday was a further request for the information needed by the Proposal Trustee to reconcile the Direct Materials from the Dynaleo inventory to sign off on the release. Dynaleo and the Proposal Trustee look forward to receiving those records from your client as soon as possible so that Dynaleo is not incurring further costs to store and maintain these materials.

Equipment Fee

You state in your letter that the Equipment Fee is being reviewed pursuant to section 6(e) of the Agreement. Section 6(e) of the Agreement only allows Cronos to holdback from paying the Equipment Fee if any Equipment purchased pursuant to the Agreement is unable to produce applicable Goods in accordance with the Specifications.

As you note in your letter, at the time we provided the notice of Disclaimer, no orders were pending from Cronos under the Agreement. All orders that were placed by Cronos had been fulfilled by Dynaleo and there were no orders in production. More than 300,000 units were provided by Dynaleo to Cronos under the Agreement, including approximately 60,000 units since the commencement of these proceedings. All batches were completed with Cronos' quality assurance team on site. Each delivery from Dynaleo passed Cronos' Q.A. inspection,

and was accepted, paid for and subsequently sold by Cronos. No order was returned for failure to meet the Specifications.

Your letter is the first time that Cronos has advised the Equipment Fee is under review. Notably, Cronos had advised that it was interested in making a bid for the Equipment in these proceedings. After the June 15, 2023, mutual termination email, Cronos made arrangements to tour the Dynaleo facility on June 20, 2023, with the purpose of contemplating a bid for the Equipment or other assets of Dynaleo. Copies of correspondence to this effect is enclosed.

We do not agree there is any validity to Cronos' section 6(e) review. Withholding the Equipment Fee appears to be an attempt by Cronos to deny Dynaleo of much needed capital so as to pressure it into walking away from its claim for the materials that cannot be repurposed. As discussed below these materials were purchased by Dynaleo at Cronos' request based on Cronos' forecasts, which Cronos ultimately could not live up to.

Timing of the Notice of Disclaimer

Your letter suggests that the amounts Dynaleo is entitled to receive from Cronos upon the termination of the Agreement is a windfall to Dynaleo or a "fabricated" claim. This is not accurate.

Upon termination of the Agreement, Cronos must reimburse Dynaleo for the materials that Cronos required that Dynaleo procure pursuant to Cronos' anticipated needs. As it turned out, Cronos' forecasted demand for gummy production from Dynaleo was massively overstated, which resulted in Dynaleo purchasing a significant amount of materials which cannot be repurposed. Cronos' inaccurate forecasting has resulted in Dynaleo incurring damages far in excess of the reimbursement for these materials that Dynaleo is now seeking.

With respect to the timing of the Disclaimer notice, Cronos sought to pick-up the Moulds and Direct Materials in early June, signaling that there would be no further orders and that the obligations of the parties under the Agreement were complete. Given that the Moulds are only to be returned upon expiry or termination of the Agreement per section 6(d), Cronos was acting as if the Agreement were terminated at that time. In response, when Dynaleo sought to enter into a mutual termination agreement, arrange the return of the Moulds, and sought payment of the fees owing to it upon termination, Cronos failed to respond.

After waiting two weeks for Cronos to respond, and with Cronos having shown its clear intention to end the contractual relationship between the parties, Dynaleo, with the consent of the Proposal Trustee, then issued the Disclaimer.

The intention to end the contractual relationship first came from Cronos. Dynaleo in no way sought to "fabricate" a claim as alleged. To the contrary, Cronos' failure to respond to the Proposal Trustee and Dynaleo is an attempt by Cronos to evade its termination obligations under the Agreement.

It appears from your letter that Cronos' position is that the parties should treat the Agreement as terminated, but with only one party (Dynaleo) complying with its post-termination obligations in returning the Moulds and Direct Materials. This position is unacceptable to Dynaleo.

Good Faith

Dynaleo has at all times acted in accordance with its obligations under the Agreement as well as its obligations to act in good faith as a debtor in these insolvency proceedings. Dynaleo continues to show reasonable accommodations to Cronos as seen from our email from Wednesday.

The records show that Cronos has been non-responsive in: (i) deliberately avoiding, delaying, or stalling the termination of the Agreement; (ii) dismissing Dynaleo's attempts at a mutual wind-up resolution of the Agreement; (iii) failing to respond to information requests of the Proposal Trustee; and (iv) ignoring the timelines required by the BIA. Threatening costs against Dynaleo in these circumstances is an attempt to impose financial impediments upon a financially challenged company, to pressure it into abandoning its legitimate claim, for the benefit of Cronos at the expense of the estate.

Such treatment is not constructive, especially when very reasonable accommodations were extended to Cronos but were refused. We hope that parties can work more constructively going forward to resolve as many issues as possible, including the transition of the Moulds and Direct Materials to Cronos, the treatment of the Equipment Fee, and an appropriate litigation schedule to hear any application Cronos may bring in respect of the Disclaimer.

Hi Jeff,

While there is currently a stay of proceedings in place preventing the exercise of rights against Dynaleo, I connected with Jill and there is mutual interest in resolving this matter quickly and to the benefit of both parties.

Please provide us with records of the Direct Materials you are claiming ownership to so we can reconcile it against existing inventory with the proposal trustee.

We note that the CMO agreement specifies that: (a) the Moulds are to be returned; and (b) Cronos is obligated to pay Dynaleo the Equipment Fee, in each case following termination or expiry of the CMO agreement. Based on our calculations, the Equipment Fee payable by Cronos on such event would be \$104,000. Further, we note that the CMO agreement states that Cronos will reimburse Dynaleo for packaging materials, raw materials that cannot be repurposed, and Dynaleo Materials that Cronos requested Dynaleo to procure. Based on our calculations, the fees payable by Cronos to Dynaleo for the materials would be \$447,960.49

In the interest of wrapping up the parties obligations under the CMO agreement, we would propose to enter into a customary termination agreement that results in the Direct Materials and the Moulds being returned early in exchange for the early payment of the Equipment and Materials Fees, which total \$551,960.49.

If this is acceptable, please let us know and provide the supporting documentation for the Direct Materials and we will provide a draft termination agreement for your review.

Hello Jill,

We received the response below from the Dynaleo team indicating that they are unable to release Cronos owned assets that are in Dynaleo's possession. These are (1) moulds for the production of our gummies, which Cronos holds an industrial design registration over (defined as the "Moulds" in the CMO agreement – attached for reference), and (2) two trade secret input materials that Cronos utilizes in the production of our gummies (collectively referred to as "Direct Materials" in the agreement).

Cronos provided these assets to Dynaleo in connection with a CMO agreement for the commercial supply of gummies from Dynaleo to Peace Naturals Project Inc. (a Cronos wholly owned subsidiary). The CMO agreement is clear that (i) PNP retains title to the Direct Materials at all times (see Section 4(a)), and (ii) PNP may retake possession of our Direct Materials at any time (see Section 4(f)).

It is of the utmost importance that we are able to collect these assets as soon as possible – these are highly confidential assets that Cronos has invested significant financial resources to develop and protect. These are not work-in-progress assets, Dynaleo has not paid for these assets, and the contract is clear that Cronos must be able to collect these assets upon demand. To be sure, the parties acknowledge in the CMO agreement that PNP would suffer immediate and irreparable harm or damage if Dynaleo continued to hold our Direct Materials following our demand to collect, and accordingly we would be entitled to a court order of possession without any need for proving damages or a bond.

We appreciate that the Dynaleo team is focused on strictly following the bankruptcy proceedings per your direction, but these assets are not Dynaleo's property, so we are once again requesting immediate access to collect our assets.

Please get back to me as soon as possible.



We are in receipt of your letter dated July 21, 2023. There are significant factual matters in dispute between the parties, including whether counsel agreed to an extension of time for the filing of our client's application for an order that the Contract Manufacturing Agreement agreed to as of the 29th day of July 2022 is not to be disclaimed. We disagree with substantially all the assertions in your letter, and do not believe that a continued exchange of correspondence will be productive to advance any resolution in this matter.

As a result, we intend to file an application on Monday, July 24, 2023, returnable July 31, 2023, when we understand you have time booked before the Court for a sale approval order and extension of the proposal period. I Michael Krestell, of the City of Thornhill, in the Province of Ontario, **MAKE OATH AND SAY THAT**:

- This Affidavit is made in support of the application (the "Application") by Dynaleo Inc. ("Dynaleo") and Dynaleo Group Services Inc. ("Dynaleo Services" and together with Dynaleo, the "Companies") returnable July 31, 2023, before the Court of King's Bench of Alberta (the "Court").
- I am the Executive Chairman and director of each of the Companies. As such, I have personal knowledge of the Companies and matters to which I depose in this Affidavit.
 Where I have relied on other sources for information, I have so stated and I believe them to be true.
- I have previously sworn an affidavit in these proceedings on May 24, 2023 (the "First Krestell Affidavit") in support of the May 30, 2023 Order (as defined below).
- 4. Unless otherwise stated, monetary figures in this Affidavit are expressed in Canadian dollars.

INTRODUCTION

- 5. As noted in the First Krestell Affidavit, on May 23, 2023, the Companies filed a notice of intention to make a proposal (the "NOI") under section 50.4(1) of *Bankruptcy and Insolvency Act* (Canada) (the "BIA"). The NOI was filed in consultation with the Companies' professional advisors to attempt to restructure the Companies for the benefit of their stakeholders and after identifying no viable alternative process due to the Companies' insolvency (the "NOI Proceeding").
- 6. Pursuant to section 50.4(8) of the BIA, the initial stay period under the NOI Proceeding was from May 23, 2023 to June 22, 2023.
- 7. On May 30, 2023, on application by the Companies, the Court granted an order (the "**May 30, 2023 Order**") that, among other things:
 - (a) appointed Harris & Partners Inc. as the proposal trustee in the NOI Proceeding (the "Proposal Trustee");

- (b) approved a sale and investment solicitation process (the "SISP") described in the Proposal Trustee's first report to the Court dated May 24, 2023 (the "First Report") and authorized and directed the Companies and the Proposal Trustee to carry out the SISP;
- (c) granted a charge, not to exceed \$200,000, as security for the fees and costs of the Proposal Trustee, its independent legal counsel, and legal counsel to the Companies;
- (d) granted a Directors' and Officers' Charge over the assets and property of Dynaleo only, to a maximum amount of \$75,000, in favour of the directors and officers of the Companies;
- (e) extended the time for filing a proposal pursuant to section 50.4(9) of the BIA up to and including August 5, 2023; and
- (f) consolidated, for procedural purposes only, the Court of King's Bench of Alberta Bankruptcy and Insolvency Estate Nos. 24-2946871 and 24-2946872 into Estate No. 24-2946872.
- 8. Capitalized terms used and not otherwise defined herein have the meanings ascribed to them in the First Krestell Affidavit.

NATURE OF APPLICATION AND OVERVIEW OF RELIEF SOUGHT

- 9. This Affidavit is made in support of the Application for orders, among other things:
 - (a) abridging the time for service of this Application and the supporting material, if necessary, and deeming service thereof to be good and sufficient;
 - (b) extending the time by which the Companies may file proposals to their creditors pursuant to section 50.4(9) of the BIA to September 19, 2023, which is the 45-day maximum period following the current deadline to do so;
 - (c) if necessary, approving a litigation schedule between the Companies and Peace Naturals Project Inc. ("PNP") to hear the Disclaimer Dispute (as defined below); and

 (d) such further and other relief as counsel may request and this Honourable Court may deem appropriate.

10. I have been advised by the Proposal Trustee that it supports this Application.

BACKGROUND

Operations and Organization

- 11. The Companies are private companies in the business of producing and distributing cannabis infused gummies.
- Dynaleo is incorporated pursuant to the *Business Corporations Act*, RSA 2000, c B-9.
 Its registered office is located at 2500-10175 101 Street NW, Edmonton, Alberta.
- 13. Dynaleo Services is incorporated pursuant to the *Canada Business Corporations Act,* RSC 1985, c C-44.
- 14. The Companies together are in the business of producing and distributing the highest quality cannabis-infused edible gummies (the "**Product**").
- 15. Dynaleo Services manages the production of the Product and at its peak employed approximately 65 full-time employees.
- Dynaleo owns the equipment and supplies necessary for the production of the Product.
 Dynaleo also holds the lease in which the Companies operate out of and is responsible for distribution of the Product to the Companies' customers.
- 17. The Companies are insolvent and each filed a Notice of Intention to Make a Proposal (the "**NOIs**") with the Official Receiver on May 23, 2023, in order to restructure their affairs for the benefit of their stakeholders.

The SISP

18. As set out in the First Krestell Affidavit beginning at paragraph 75, and the First Report beginning at paragraph 36, the Companies, with support of the Proposal Trustee, sought and obtained approval of the SISP to undergo a restructuring process and allow all qualified and interested parties to solicit interest in, and opportunities for, a sale of, or investment in, all or part of the Companies' assets and business operations (the "**Opportunity**").

19. The Companies commenced the SISP in June 2023. The SISP was designed to be flexible, such that any proposed transaction structure would be considered, whether it be for shares, or assets of the Companies, or any combination of these transactions.

20. The SISP milestones are:

21. As detailed in the First Report, the Companies and Proposal Trustee worked together to prepare a list of Potential Bidders, including: (i) parties that have approached the Companies and/or the Proposal Trustee indicating an interest in the Opportunity, (ii) strategic and financial parties who the Companies, in consultation with the Proposal Trustee, believe may be interested in purchasing all or part of the Business and Property or investing in the Companies pursuant to the SISP.

Results of the SISP

- 22. In June 2023, the Proposal Trustee circulated to interested parties a process summary (the "Teaser Letter") describing the Opportunity, outlining the process under the SISP and inviting recipients of the Teaser Letter to express their interest in the opportunity. A copy of the Teaser Letter is attached to my Affidavit as Exhibit "A".
- 23. Interested parties were requested to submit an executed non-disclosure agreement, letter setting forth the required information as laid out in the SISP, and a form of financial disclosure and credit quality support to enable the Companies and Proposal Trustee to understand the Potential Bidder's ability to consummate a potential transaction.
- 24. If the Companies, in consultation with the Proposal Trustee, determined that a Potential Bidder satisfied the requirements of the SISP, then the Potential Bidder was deemed to be a "**Phase 1 Qualified Bidder**".

- A Phase 1 Qualified Bidder that wished to pursue the opportunity further was required to deliver a non-binding letter of intent (an "LOI") to the Proposal Trustee by 5:00 p.m.
 MST on June 23, 2023 (the "Phase 1 Bid Deadline").
- 26. Five Phase 1 Qualified Bidders submitted an LOI by the Phase 1 Bid Deadline.
- Following the Phase 1 Bid Deadline, the Companies, in consultation with the Proposal Trustee, assessed the LOIs and selected certain parties to advance as a "Phase 2 Qualified Bidder" in the SISP.
- 28. Two Phase 2 Qualified Bidders submitted binding offers by the Bid Deadline (each, a "Binding Offer"). Following receipt of the Binding Offers, the Companies, with the assistance of the Proposal Trustee, have been working with the Phase 2 Bidders to reconcile certain closing conditions in their respective bids.
- 29. Pursuant to the SISP, any deadlines, including the Closing Date Deadline, can be extended in order to pursue the two binding offers in hopes of closing the transaction.
- 30. The Companies, with the assistance of the Proposal Trustee, anticipates returning to this Court in the near future for approval of one of the transactions with a Phase 2 Qualified Bidder.

DISCLAIMER DISPUTE

- 31. On July 29, 2022, Dynaleo entered into a Contract Manufacturing Agreement (the "Manufacturing Contract") with PNP, a subsidiary of Cronos Group Inc. ("Cronos"), which is a large brand leader in the cannabis-infused edible gummies business. The Manufacturing Contract was set to expire July 29, 2023.
- 32. The Manufacturing Contract was for the Companies to produce Product for PNP.
- 33. As part of the Manufacturing Contract, Dynaleo was required by PNP to make significant capital expenditures to acquire specialized machinery to meet the volume and Product specifications for PNP.
- 34. In return for these expenditures by Dynaleo, it was a term of the Manufacturing Contract that upon the expiration or termination of the Manufacturing Contract, PNP agreed to pay Dynaleo an equipment fee (the "**Equipment Fee**").

- 35. In addition, it was a term of the Manufacturing Contract that upon the termination of the Manufacturing Contract, PNP would reimburse Dynaleo for certain costs of PNP specific materials that PNP required that Dynaleo purchase based on PNP's purchasing forecasts (the "Materials Fee").
- 36. Beginning on June 1, 2023, Cronos requested the return or destruction of certain of its property that was required for the manufacturing of Product for PNP, signaling that PNP would not be making further orders for Product despite there being approximately two months' remaining on the Manufacturing Contract.
- 37. As a result, on June 15, 2023, Dynaleo sought to mutually terminate the Manufacturing Contract and requested payment of the Equipment Fee and Materials Fee.
- 38. After waiting two-weeks and receiving no response on Dynaleo's mutual termination request, and with PNP not having made any more orders under the Manufacturing Contract, on June 28, 2023, with the approval of the Proposal Trustee, the Companies issued a notice of disclaimer to PNP in respect of the Manufacturing Contract (the "Disclaimer") in accordance with s 65.11 of the BIA. A copy of the Disclaimer is attached as Exhibit "B".
- 39. Concurrently with the Disclaimer, solicitors for the Companies sent PNP a demand for the Equipment Fee and Manufacturing Fee, each of which is payable upon the termination of the Manufacturing Contract (the "Demand Letter"). A copy of the Demand Letter is attached as Exhibit "C".
- 40. On June 30, 2023, in-house counsel to PNP requested that the Companies provide written reasons ("**Request for Written Reasons**") for the Disclaimer within five days pursuant to section 65.11(9) of the BIA. The Request for Written Reasons is attached to my Affidavit as Exhibit "**D**".
- 41. In accordance with the timelines required by section 65.11(9) of the BIA, the Companies provided written reasons (the "Written Reasons") for the Disclaimer to PNP on July 5, 2023. A copy of the Written Reasons is attached as Exhibit "E".
- 42. On July 20, 2023, counsel for Cronos and PNP sent a letter (the "**July 20 Letter**") to counsel for the Companies requesting, among other things, that the Companies withdraw the Disclaimer. A copy of the July 20 Letter is attached as Exhibit "**F**".

- 43. On July 21, 2023, counsel for the Companies wrote to counsel to Cronos and PNP in response to the July 20 Letter (the "July 21 Letter"). A copy of the July 21 Letter is attached as Exhibit "G".
- 44. I understand that Cronos and PNP intend to bring an application to: (i) extend the 15day period for which it can file an application to dispute the Disclaimer, and (ii) if the extension is granted, seek an order declaring that the Manufacturing Contract cannot be disclaimed (the "**Disclaimer Dispute**").
- 45. On July 24, 2023, counsel to Cronos and PNP wrote to counsel for the Companies (the "July 24 Letter") indicating that they intend to file an application in relation to the Disclaimer Dispute that day, returnable July 31, 2023. A copy of the July 24 Letter is attached to my Affidavit as Exhibit "H".
- 46. In the event that Cronos and PNP proceed with the Disclaimer Dispute, the Companies may seek approval of a litigation schedule to ensure that the Disclaimer Dispute is determined expeditiously and in any event prior to the expiry of the time for filing a proposal.

RELIEF REQUESTED

Extension of Time to File a Proposal

- 47. An extension of time for the Companies to file a proposal or proposals is a material component of the NOI Proceeding to allow the Companies to restructure their affairs, including negotiating and completing the SISP and closing one of the transaction of the Phase 2 Qualified Bidders.
- 48. Since filing the NOI, the Companies have been diligently complying with the various requirements under the BIA, including:
 - (a) preparing and analyzing the list of creditors;
 - (b) providing the Proposal Trustee with access to the Companies' senior employees and books and records;
 - (c) completing a cash flow forecast to the week ending August 18, 2023;
 - (d) implementing and executing the SISP; and

- (e) working with the Proposal Trustee to review and analyse the Binding Offers submitted in the SISP in order to pursue one of the transactions.
- 49. The Companies are working in good faith and with a view to maximize value for the Companies' creditors and other stakeholders.
- 50. I understand that in order to continue to work toward the formulation and filing of a proposal or proposals, the Companies will require an extension of the time period within which they may file a proposal or proposals to their creditors. In this regard:
 - (a) the Companies have acted and are acting in good faith and with due diligence both in the period prior to and since filing of the NOIs; and
 - (b) an extension will enhance the Companies' abilities to make a viable proposal or proposals following the completion of a transaction.

CONCLUSION

- 51. I swear this Affidavit in support of the Application and any other proper purpose in connection with these NOI proceedings.
- 52. I was not physically present before the commissioner when swearing this Affidavit but was linked with the commissioner utilizing video technology and that the protocol described in the Alberta Court of King's Bench Notice to the Profession and Public dated March 25, 2020 with respect to remote commissioning of Affidavits was followed.



REASONS FOR DISCLAIMER PURSUANT TO SECTION 65.11(9) OF THE BIA

To: Peace Naturals Project Inc. ("PNP")

Whereas:

- A. On May 23, 2023, Dynaleo Inc. ("Dynaleo" or the "Company") commenced proposal proceedings (the "Proposal Proceedings") under the Bankruptcy and Insolvency Act (the "BIA") and Harris & Partners Inc. was appointed as the proposal trustee ("Proposal Trustee") in the BIA Proceedings ("Proposal").
- B. On June 28, 2023, in accordance with subsection 65.11(1) of the BIA, the Company gave PNP notice of its intention to disclaim or resiliate a Contract Manufacturing Agreement dated July 29, 2022 made between PNP and the Company (**"Agreement**").
- C. On June 30, 2023 at 4:29 pm (MDT), PNP requested reasons in writing for the disclaimer of the Agreement pursuant to subsection 65.11(9) of the BIA. The requested reasons are set out below.

Reasons for Disclaimer

The Company considered a number of factors in determining to disclaim the Agreement including:

- Leading up to and following the commencement of the Proposal Proceedings, the Company, in consultation with the Proposal Trustee, undertook a review of certain contracts to consider whether disclaiming them would assist improve the Company's challenging liquidity position and/or facilitate the prospect of a viable proposal being made by the Company.
- 2. There was limited on-going business operations occurring between the Company and PNP pursuant to the Agreement prior to the commencement of the Proposal Proceedings. During the Proposal Proceedings, the Company fulfilled two orders from PNP, identified as Order Number: 2023-00893-00 and Order Number: 2023-00893-01 ("Orders"), which PNP has paid for in full in accordance with the terms of the Agreement. Since that time there has been no further business occurring between the two parties and no further business will occur as the Company has ceased fulfilling orders.
- 3. As part of the Proposal Proceedings, the Company commenced a Court-approved sale and investment solicitations process (the "SISP") to seek to identify a potential sale or restructuring transaction that would maximize the value of the Company's business for the benefit of the Company and its stakeholders. Prior to determining whether to disclaim the Agreement, the Company waited for the results of the first phase of the SISP. Thereafter, the Company considered the letter of intent submitted by PNP and those received from other partied and considered whether disclaiming the Agreement would negatively impact the SISP.
- 4. The Company determined that the disclaimer of the Agreement would not negatively impact the outcome of the SISP.
- 5. The Company reviewed the nature, terms, and purpose of the Agreement in detail, and believes that the Agreement does not constitute any of the types of contracts that are exceptions to the statutory regime of Section 65.11 of the Act.
- 6. The Company believes disclaiming the Agreement will improve its liquidity and enhance the prospects of a viable proposal being made by the Company.

7. The Company consulted with the Proposal Trustee and the Proposal Trustee reviewed and approved of the Company's disclaimer of the Agreement prior to it being issued.

As you are aware, we are counsel to Cronos Group Inc. ("**Cronos**") and Peace Naturals Project Inc. ("**PNP**") in connection with the above-noted matters. We are writing with respect to the disclaimer notice (the "**Disclaimer**") provided by Dynaleo Inc. ("**Dynaleo**"), dated June 28, 2023, which states that Dynaleo intends to disclaim the Contract Manufacturing Agreement between Dynaleo and PNP agreed to as of the 29th day of July 2022 (the "**Agreement**"). Capitalized terms used but not otherwise defined herein shall have the meanings given to them in the Agreement.

We are also in receipt of your e-mail dated July 19, 2023 (the "E-mail") wherein you condition an earlier agreement to extend our client's time to object to the Disclaimer (which we understand was agreed to without details with former counsel to Cronos and PNP) and the return of Moulds and Direct Materials on payment of the Equipment Fee by our client.

Based on our review of the materials filed in the Proceedings, including the "Reasons for Disclaimer Pursuant to Section 65.11(9) of the BIA" provided by Dynaleo to our client on July 5, 2023, the Disclaimer does not appear to serve any legitimate purpose under the *Bankruptcy and Insolvency Act*, RSC 1985, c B-3 ("**BIA**"). Further, there is no evidence to suggest that the Disclaimer "would enhance the prospects of a viable proposal being made in respect of" Dynaleo.

As you know, at the time of the Disclaimer, there were no ongoing performance obligations of Dynaleo to PNP under the Agreement, which will expire on its terms on July 29, 2023. On expiration of the Agreement, the only amounts which may be owing from PNP to your client would be the Equipment Fee, which is under review by PNP in light of Section 6(e) of the Agreement. It appears that the Disclaimer was issued, with a view to creating a "termination" of the Agreement, one day prior to its expiration in an attempt by your client to fabricate a claim against our client which is not supported by the Agreement or the general requirement that a debtor in BIA proposal proceedings must act in good faith in carrying out its restructuring proceedings.

Our client is not prepared to accept the terms set out in the E-mail for an extension of time to object to the Disclaimer. If your client is not prepared to withdraw the Disclaimer immediately, our client intends to make an application to the Court of King's Bench of Alberta for an order: (i) that the Agreement cannot be disclaimed; (ii) requiring the immediate return of the Moulds and Direct Materials; and (iii) declaring that no amounts are owing from our client to Dynaleo. In any such application, our client intends to seek costs as against your client.

We are counsel to Dynaleo Inc. and Dynaleo Group Services Inc. (collectively, "**Dynaleo**"). We write in response to your letter dated July 20, 2023, as counsel to Cronos Group Inc. and Peace Naturals Project Inc. (collectively, "**Cronos**"). Capitalized terms used herein and not otherwise defined have the meanings given to them in the Contract Manufacturing Agreement dated July 29, 2022 between Dynaleo and Cronos (the "**Agreement**") or your letter.

Extension of time to object to Disclaimer

We disagree with the assertion that Dynaleo agreed to an indefinite extension of time for Cronos to bring an application to object to the Disclaimer. In anticipation of being retained by Cronos, Torys LLP informally asked for an extension to object to the Disclaimer if they were ultimately retained and instructions were ultimately received to do so. This counsel was to contact me once retained and instructions were received to formalize the request. No call was made and this counsel was ultimately not engaged for this issue. No agreement as to the terms for an extension for Cronos to object to the Disclaimer was ever established. Enclosed is correspondence between me and Torys LLP showing that Torys LLP never received instructions regarding the Disclaimer extension request.

The first time we received confirmation that Cronos intended to dispute the Disclaimer was a full week later, when your office was engaged. Cronos' first official request for an extension from its retained counsel that had instructions was made July 17, 2023, four days after the 15 day deadline for Cronos to file its application under s. 65.11(3) of the *Bankruptcy and Insolvency Act* (Canada) ("**BIA**") had expired.

Cronos at all times was aware of the strict timelines required by the BIA pertaining to disclaimer notices and held Dynaleo to those strict timelines when it requested written reasons



31

for the Disclaimer. Enclosed is a copy of this correspondence from Cronos Deputy General Counsel to this effect.

To date, no extension of time to bring a s. 65.11(3) BIA application was agreed to between the parties. Even if a reasonable extension was granted by Dynaleo as alleged, waiting a full week to confirm Cronos' intentions to dispute the Disclaimer is unreasonable. Cronos is out of time to bring an application objecting to the Disclaimer, which, but for Cronos' early termination of the Agreement discussed below, otherwise would have become effective on July 28, 2023, by operation of s. 65.11(6)(a) of the BIA.

Early Termination of the Agreement by Cronos

As you know, section 6(d) of the Agreement states "Upon expiration or termination of this Agreement, Dynaleo shall ship the Moulds to [Cronos] as soon as reasonably practicable . . . or as otherwise mutually agreed by the Parties in writing". It has always been the intention of Dynaleo to return the Moulds following termination of the Agreement. Your letter is a further request from Cronos for the Moulds prior to the expiry of the Agreement. We accept this request as confirmation the Agreement has been terminated effective immediately.

Given this termination of the Agreement, Dynaleo has initiated steps to return the Moulds to Cronos. Dynaleo expects to be in a position to deliver the Moulds to Cronos by mid-next week. If Cronos wishes to pick-up the Moulds, please advise.

With respect to the Direct Materials, since early June Dynaleo has tried to facilitate the winddown of the contractual relationship and the return of the Direct Materials to Cronos. As has been repeatedly stated to your client by Dynaleo and the Proposal Trustee, before Dynaleo can release the Direct Materials to Cronos, the Proposal Trustee needs to complete an inventory to confirm which property Cronos has an ownership interest in. Enclosed are emails from June 8, 2023, and June 15, 2023, to Cronos from the Proposal Trustee and Dynaleo, respectively, requesting this information. Cronos did not respond to either of these emails.

My email from Wednesday was a further request for the information needed by the Proposal Trustee to reconcile the Direct Materials from the Dynaleo inventory to sign off on the release. Dynaleo and the Proposal Trustee look forward to receiving those records from your client as soon as possible so that Dynaleo is not incurring further costs to store and maintain these materials.

Equipment Fee

You state in your letter that the Equipment Fee is being reviewed pursuant to section 6(e) of the Agreement. Section 6(e) of the Agreement only allows Cronos to holdback from paying the Equipment Fee if any Equipment purchased pursuant to the Agreement is unable to produce applicable Goods in accordance with the Specifications.

As you note in your letter, at the time we provided the notice of Disclaimer, no orders were pending from Cronos under the Agreement. All orders that were placed by Cronos had been fulfilled by Dynaleo and there were no orders in production. More than 300,000 units were provided by Dynaleo to Cronos under the Agreement, including approximately 60,000 units since the commencement of these proceedings. All batches were completed with Cronos' quality assurance team on site. Each delivery from Dynaleo passed Cronos' Q.A. inspection,



and was accepted, paid for and subsequently sold by Cronos. No order was returned for failure to meet the Specifications.

Your letter is the first time that Cronos has advised the Equipment Fee is under review. Notably, Cronos had advised that it was interested in making a bid for the Equipment in these proceedings. After the June 15, 2023, mutual termination email, Cronos made arrangements to tour the Dynaleo facility on June 20, 2023, with the purpose of contemplating a bid for the Equipment or other assets of Dynaleo. Copies of correspondence to this effect is enclosed.

We do not agree there is any validity to Cronos' section 6(e) review. Withholding the Equipment Fee appears to be an attempt by Cronos to deny Dynaleo of much needed capital so as to pressure it into walking away from its claim for the materials that cannot be repurposed. As discussed below these materials were purchased by Dynaleo at Cronos' request based on Cronos' forecasts, which Cronos ultimately could not live up to.

Timing of the Notice of Disclaimer

Your letter suggests that the amounts Dynaleo is entitled to receive from Cronos upon the termination of the Agreement is a windfall to Dynaleo or a "fabricated" claim. This is not accurate.

Upon termination of the Agreement, Cronos must reimburse Dynaleo for the materials that Cronos required that Dynaleo procure pursuant to Cronos' anticipated needs. As it turned out, Cronos' forecasted demand for gummy production from Dynaleo was massively overstated, which resulted in Dynaleo purchasing a significant amount of materials which cannot be repurposed. Cronos' inaccurate forecasting has resulted in Dynaleo incurring damages far in excess of the reimbursement for these materials that Dynaleo is now seeking.

With respect to the timing of the Disclaimer notice, Cronos sought to pick-up the Moulds and Direct Materials in early June, signaling that there would be no further orders and that the obligations of the parties under the Agreement were complete. Given that the Moulds are only to be returned upon expiry or termination of the Agreement per section 6(d), Cronos was acting as if the Agreement were terminated at that time. In response, when Dynaleo sought to enter into a mutual termination agreement, arrange the return of the Moulds, and sought payment of the fees owing to it upon termination, Cronos failed to respond.

After waiting two weeks for Cronos to respond, and with Cronos having shown its clear intention to end the contractual relationship between the parties, Dynaleo, with the consent of the Proposal Trustee, then issued the Disclaimer.

The intention to end the contractual relationship first came from Cronos. Dynaleo in no way sought to "fabricate" a claim as alleged. To the contrary, Cronos' failure to respond to the Proposal Trustee and Dynaleo is an attempt by Cronos to evade its termination obligations under the Agreement.

It appears from your letter that Cronos' position is that the parties should treat the Agreement as terminated, but with only one party (Dynaleo) complying with its post-termination obligations in returning the Moulds and Direct Materials. This position is unacceptable to Dynaleo.



Good Faith

Dynaleo has at all times acted in accordance with its obligations under the Agreement as well as its obligations to act in good faith as a debtor in these insolvency proceedings. Dynaleo continues to show reasonable accommodations to Cronos as seen from our email from Wednesday.

The records show that Cronos has been non-responsive in: (i) deliberately avoiding, delaying, or stalling the termination of the Agreement; (ii) dismissing Dynaleo's attempts at a mutual wind-up resolution of the Agreement; (iii) failing to respond to information requests of the Proposal Trustee; and (iv) ignoring the timelines required by the BIA. Threatening costs against Dynaleo in these circumstances is an attempt to impose financial impediments upon a financially challenged company, to pressure it into abandoning its legitimate claim, for the benefit of Cronos at the expense of the estate.

Such treatment is not constructive, especially when very reasonable accommodations were extended to Cronos but were refused. We hope that parties can work more constructively going forward to resolve as many issues as possible, including the transition of the Moulds and Direct Materials to Cronos, the treatment of the Equipment Fee, and an appropriate litigation schedule to hear any application Cronos may bring in respect of the Disclaimer.

Hi Jeff,

While there is currently a stay of proceedings in place preventing the exercise of rights against Dynaleo, I connected with Jill and there is mutual interest in resolving this matter quickly and to the benefit of both parties.

Please provide us with records of the Direct Materials you are claiming ownership to so we can reconcile it against existing inventory with the proposal trustee.

We note that the CMO agreement specifies that: (a) the Moulds are to be returned; and (b) Cronos is obligated to pay Dynaleo the Equipment Fee, in each case following termination or expiry of the CMO agreement. Based on our calculations, the Equipment Fee payable by Cronos on such event would be \$104,000. Further, we note that the CMO agreement states that Cronos will reimburse Dynaleo for packaging materials, raw materials that cannot be repurposed, and Dynaleo Materials that Cronos requested Dynaleo to procure. Based on our calculations, the fees payable by Cronos to Dynaleo for the materials would be \$447,960.49

In the interest of wrapping up the parties obligations under the CMO agreement, we would propose to enter into a customary termination agreement that results in the Direct Materials and the Moulds being returned early in exchange for the early payment of the Equipment and Materials Fees, which total \$551,960.49.

If this is acceptable, please let us know and provide the supporting documentation for the Direct Materials and we will provide a draft termination agreement for your review.

Hello Jill,

We received the response below from the Dynaleo team indicating that they are unable to release Cronos owned assets that are in Dynaleo's possession. These are (1) moulds for the production of our gummies, which Cronos holds an industrial design registration over (defined as the "Moulds" in the CMO agreement – attached for reference), and (2) two trade secret input materials that Cronos utilizes in the production of our gummies (collectively referred to as "Direct Materials" in the agreement).

Cronos provided these assets to Dynaleo in connection with a CMO agreement for the commercial supply of gummies from Dynaleo to Peace Naturals Project Inc. (a Cronos wholly owned subsidiary). The CMO agreement is clear that (i) PNP retains title to the Direct Materials at all times (see Section 4(a)), and (ii) PNP may retake possession of our Direct Materials at any time (see Section 4(f)).

It is of the utmost importance that we are able to collect these assets as soon as possible – these are highly confidential assets that Cronos has invested significant financial resources to develop and protect. These are not work-in-progress assets, Dynaleo has not paid for these assets, and the contract is clear that Cronos must be able to collect these assets upon demand. To be sure, the parties acknowledge in the CMO agreement that PNP would suffer immediate and irreparable harm or damage if Dynaleo continued to hold our Direct Materials following our demand to collect, and accordingly we would be entitled to a court order of possession without any need for proving damages or a bond.

We appreciate that the Dynaleo team is focused on strictly following the bankruptcy proceedings per your direction, but these assets are not Dynaleo's property, so we are once again requesting immediate access to collect our assets.

Please get back to me as soon as possible.

We are in receipt of your letter dated July 21, 2023. We disagree with substantially all the assertions in your letter, and do not believe that a continued exchange of correspondence will be productive to advance any resolution in this matter.
